

Los Gatos-Saratoga AAUW: The 1960s

Our skirts were shorter and our hair was longer. The branch was incorporated September 22, 1960 as a non-profit organization. Our interests grew, and our membership expanded up to 350. We studied the gifted child throughout 1960 and 1961, water conservation in 1962, and new teacher credential qualifications. A Gourmet Group began and took responsibility for the April tea. We sponsored a Children's Art Fair for several years. The play reading group entertained us at general meetings. There were three book review sections: morning, afternoon, and couples.

The AAUW Investment Section made money playing the stock market on paper while studying and doing research on stocks, mutual funds, and estate planning. Our Occident and Orient Section presented a program on the history, culture and religion of Tibet.

Mrs. James Richards was honored in 1961 for her 70 year membership in AAUW with a Life Membership.

Both **Ruth Cannon** and **Louise Cooper**, AAUW members, filed for candidates as trustees at Los Gatos High School District. In 1964-65 **Mary Drake** represented AAUW on the State Committee to redefine and organize higher



education in California by defining the role of community and state colleges and the university system.

A new travel section began with **Isobel Darrow** and **Bette Sample** as co-chairs; **Cathy Foscatto** carried on as Chair when they retired. Many AAUW meetings took place at West Valley College. **Gladys Armstrong** opened her home for the early Yuletide Open House, as did **Betty Hall**.

In 1969 a study program was started on Testing Values in a Changing Society; **Martha Beverett** and **Lucia Callis** were co-chairs. Among the topics studied were young people of today, prejudice, drugs and minorities. **Louise Webb** submitted the committee report to the Association Program Development Chair in Washington, D.C., and received a letter calling it "Well done ... a good job."

About the Authors . . .



Donia Bijan

Donia Bijan is a San Francisco Bay Area chef who left Iran in 1978 when her parents' lives were threatened by the Islamic Revolution. Her family settled in the Bay Area and was advised not to return to Iran.

After graduating from UC Berkeley in 1984, Donia went to Paris to attend the Cordon Bleu. Determined to pursue a culinary career, she secured apprenticeships in France's three star kitchens before returning to San Francisco to preside over many of the city's acclaimed restaurants and earning awards for her French inspired cuisine. In 1994 she realized her dream of opening of her own restaurant, L'Amie Donia, a celebrated French bistro in Palo Alto.

Since closing her restaurant in 2004, Ms. Bijan has divided her days between raising her son, catering, and writing a memoir. In her memoir she draws from her Persian, French, and American pantry to thread ties between cultures.



Keith Raffel

Keith Raffel has watched over the CIA, supported himself at the racetrack, founded a software company, taught writing to college freshmen, run for Congress, and sold DNA sequencing.

Specifically, Raffel served as counsel to the Senate Intelligence Committee overseeing the secret world of the CIA, NSA, and other clandestine three-lettered agencies. He also worked on legislation with Senators Biden (*as he was then*), Kennedy, Goldwater, and Bayh.

In these varied pursuits, Raffel came across enough ambition, envy, and lucre here in Silicon Valley to convince him it was a terrific place to set a crime novel.

He became a published author in 2006 with *Dot Dead*. His latest book, *Temple Mount*, has been called "tightly woven, lightning-paced, and touching the heart", by San Francisco author Cara Black

He can be found on his laptop and power-drinking green tea at a café near his home in Palo Alto.



Pamela Spahr

Pamela Spahr promoted product understanding by defining and integrating high quality, user-centric information. A former high-tech executive from the San Francisco Bay area, Spahr was not prepared to assume responsibility for managing her husband who suffered from series of strokes and was subsequently diagnosed with dementia.

Eventually, she discovered techniques that became her survival toolkit and lead to the writing of an eBook, *Caregiver's Survival Toolkit*, released in April, 2014.

Now she teaches those techniques to other caregivers. Spahr speaks nationally on caregiving, writes on aging nationally, and teaches groups on everything from introductory caring to expert level problem solving for healthcare professionals.

Spahr is the founder of Inspired Caregivers, the business she launched in September 2013 .

Catherine "Kay" Ruf

August 5, 1936 – October 21, 2015
Resident of Saratoga

Kay was born in Willimantic, Connecticut, the eldest of five children, to Dorothy Ashe, a nurse, and John Francis "Fran" Dillon, an insurance agent. As a straight "A" student at Windham High School, she earned the Philip Lauter Scholarship to the University of Connecticut and she graduated with high honors in 1957.

She met the love of her life, Egon T. Ruf, at Univ. of Conn and they shared a fifty-two year marriage before Egon's death in 2012. In 1975, they started E&K Scientific Products, Inc., a pioneer Silicon Valley business, selling to the Bay Area medical research and biotech industries. E&K continues to thrive under their youngest son, Brian.

Kay loved music and singing. She was an avid shell and rock collector, and loved beachcombing. She was a long-time member of the Sacred Heart Church parish in Saratoga (where she sang in the choir and served as a lector), the American Association of University Women and the Foothill Club.

She is survived by her sons Mike of Wisconsin, Kevin (Asli) of Ojai, CA and Brian (Marnie) of Santa Cruz, CA, her brothers John Dillon (Marilyn) of Maryland, and Michael Dillon (Meridith) of North Carolina, her sister Maureen Dillon of Connecticut, and her nine beloved grandchildren. She was also predeceased by her sister, Dorothy Dillon Chase, of Gainesville, Florida.

Elected Officials Address the AAUW and LWV

Our first co-sponsored program for the year on November 7 was quite successful as our branch and the League of Women Voters heard nine different elected officials explain what they see as the major concerns for both the state of California and local governments.

While there were some differences from one jurisdiction to another, there was a common understanding that Silicon Valley is facing serious transportation issues, a lack of affordable housing, and the consequences of the historic drought. To some extent these problems are related to the strong employment picture in the Valley with people commuting to work and bidding up the cost of local housing, but many people are being priced out of the housing market and everyone is affected by the drought. All the jurisdictions have a role to play in addressing the needs of their residents, and all the speakers truly appreciate the citizen involvement that this kind of meeting demonstrates.

The audience was quick to ask several questions of their elected representatives, then had an opportunity to meet them one-on-one both before and after the formal presentation.

Our thanks to **Ann Suyeyasu**, our official greeter; to **Gail Pedersen** for bringing membership materials; and to **Judy Borlase, Marilyn Fuller, Ann Griffin, and Joyce Sogg**, who provided refreshments.
