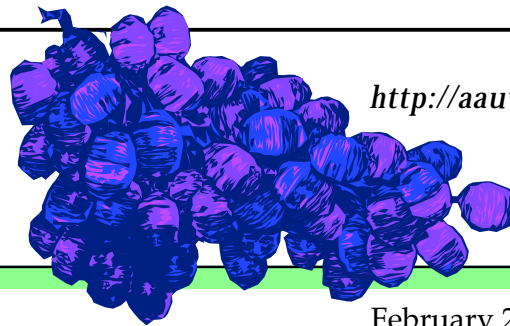

## AAUW-CA Lobbyist to Speak Locally

Charlotte Newhart, official AAUW California advocate, will speak on Saturday, February 6, 2010. Ms. Newhart will discuss the topic: **"Public Input – Better Output: Legislation You Can Support for CA Women and Families."**

She has been working in four California areas: legislative, state regulatory, state administrative decision making and action, and the state budget. The issues that Ms. Newhart is fighting in Sacramento for are:

- Constitutional protection of civil rights
- Vigorous enforcement of regulations on gender equity
- Public education and lifelong learning
- Research and reform to improve student achievement
- Access to health care and the expansion of patient rights
- Greater access to high quality, affordable family care services
- Freedom from violence and fear in homes, schools, workplaces and communities

Ms. Newhart's expertise is in the political process and accomplishing changes for improved state programs and services while preventing those changes that would undermine advances. Find out how you can help in this mission.

## Protect Social Security and Medicare

Social Security is one of our country's most successful anti-poverty programs, providing benefits to children, disabled workers, surviving spouses, and retirees. Without Social Security benefits, more than half of older women would fall into poverty. However, there is growing movement in the Senate to reduce the federal budget deficit by cutting Social Security and Medicare programs, which would have a devastating and disproportionately negative impact on women. Urge your senators to oppose cuts to these programs.

Several senators have threatened to hold up other budget legislation unless a debt-reducing, entitlement-cutting commission is established. This commission's recommendations would be crafted behind closed doors, the normal process of debate would be ignored, and no amend-

ments would be allowed before the vote. This 'all or nothing' commission would fast-track cuts to these critical programs. AAUW opposes this clearly undemocratic, non-transparent commission process.

The Social Security program continues to run a surplus and is expected to be able to pay full benefits for another 30 years without affecting the deficit, giving Congress ample time to make adjustments to future benefits through the normal legislative process. And the best way to reign in the costs of Medicare is through the current health care reform bills, not by cutting benefits to the millions of Americans who depend on the program for their health care.

**TAKE ACTION!** Urge your senators to oppose the formulation of an undemocratic commission that would target Social Security and Medicare programs.

## ‘How to Sell on eBay?’

Guest Speaker for the Independent Women Interest Group

On January 6, a group of eighteen of us (the largest attendance ever) met at Joan Kjemtrup’s home to listen to a presentation by Fritz Model on “*How to Sell on eBay.*”

Fritz began his talk by relating his experience on how he successfully sold his car on eBay. He then gave us a step-by-step tutorial on how to sell an item on eBay. To demonstrate the process, Fritz listed a new pair of children’s shoes that he did not need and went through each step to create the eBay listing.

1. Describe the item.
2. Insert a picture of the item.
3. Select the method of payment.
4. Select the method of shipment.
5. Decide whether to list the item at a fixed price to sell right away or list the item for auction.
6. Finish the listing.

Fritz took all of our questions and gave us a list of resources to learn more about the selling process. It was a very informative meeting and we all thoroughly enjoyed the presentation.

## Recollections of the 1970’s

The word for this decade was EQUALITY. Guided by those beliefs, the Los Gatos/Saratoga Branch devoted their efforts in the next biennium to the preservation of individual liberties. 1971 brought official support for the Equal Rights Amendment (ERA), and was made the Association’s top priority in 1975.

The Branch started some new sections—BEAUTIFUL YOU and HOUSE BEAUTIFUL.

During 1971-1973 a Focus Group was begun which was community-oriented as well as action-oriented. Marlene Duffin, Cynthia Vailey and Jan Kimball were nominated for the Outstanding Young Women of America.

Peggy Corr was appointed the first woman on the Saratoga City Council. The Branch had over 500 members.

### 1975-1976

The Branch became politically active by protesting to Saratoga City Council the \$130 per year charge for the city agenda packets. The Branch actively supported a new city library on the

site at Saratoga and Fruitvale Avenues.

Our Branch cosponsored with the League of Women Voters a CANDIDATES FORUM for Santa Clara County voters to meet local, county, state and federal office candidates.

The Branch opposed the construction of a West Valley College stadium.

### 1977-1978

The topics studied under the Presidency of Marjorie Bunyard included Politics of Food, Living with Less, Women as Agents of Change and Redefining Goals in Education.

During the end of the 70’s there was controversy about the AAUW (U.S.) requesting more representation and “say” in the International Federation of University Women (IFUW). We were paying most of the funding but did not have a representative on this Board. Many letters were written to the IFUW in Geneva.

Discussions on men being invited to belong to AAUW went on for months and culminated in a negative vote at the Albuquerque Convention.

## AAUW Key 2009 Legislative Accomplishment

Last year, AAUW was instrumental in the passage of several pieces of legislation, including the Lilly Ledbetter Fair Pay Act, the Matthew Shepard and James Byrd, Jr. Hate Crimes Prevention Act, and the American Recovery and Reinvestment Act, which provides funding for job training, a \$500 Pell grant increase, and an unemployment insurance increase.

“Overall, AAUW is pleased to report that Washington has heard the concerns of American women and taken the right steps toward addressing some of our nation’s most serious problems with respect to economic security,

work-life balance, education, and civil rights,” said AAUW Executive Directory Linda D. Hallman, CAE. “However, much work remains to be done as we push for sustainable change and equity for women and girls.”

Our 2009 successes include House passage of the Federal Employees Paid Parental Leave Act, Student Aid and Fiscal Responsibility Act, which would provide employees seven paid sick-leave days per year. Disappointments include the House Stupak vote, Senate efforts to advance school vouchers, and Senate failure to pass the Paycheck Fairness Act.

## Homeless Committee Had a Successful and Fun Holiday Brunch

Our Holiday Brunch was a resounding success. The Georgia Travis Center is going through interesting changes which allows for a varied population participating in the many activities being offered. This agency is no longer just a small venue for homeless women and children to find help and solace, but is now opening to a number of community projects to help not only the homeless, but low-income people as well.

Because we are committed to homeless women and children and because we have collected not only funds but gifts for the women with that understanding, we decided to have our holiday party at the Commercial Street Inn, the overnight shelter across

the street from the Georgia Travis Center. This, too, is part of the InnVision agency. We could be assured that we would be providing for homeless women and their children only.

Our Committee put together a very tasty meal and after its consumption, the fun began. The only public room in that building is the dining room that provides seating space for approximately 25 women. It was very snug as we passed out the gifts. But this made for a more intimate feeling from years past, when we had a large room and everyone was spread out. This year committee members were face-to-face with the women and were a closer to their enjoyment as they opened their

gifts. It was not they and we; it was just "we."

These women are more than happy to tell you their story and what led to their being without a home. The stories are tragic and painful but at the meal they were laughing, joking and kidding around. One of the women was celebrating her birthday and was so happy to have gifts. I don't think one of us left that night without truly feeling the holiday spirit, not because of what we did for them, but what they did for us.

### Recipe

## Crab Louis

It's Dungeness Crab season! The crabs are plentiful from January through early March. Growing up my family made Crab Louis Salads every year at this time of year. This recipe was in the Sunset Magazine about 25 years ago and it has the recipe for traditional Louis Dressing.

Makes: 4 servings

4 bibb lettuce cups  
 1 large head iceberg lettuce, shredded  
 2 to 3 cups cooked crab meat, chilled  
 2 large tomatoes, cut into wedges  
 2 hard-boiled eggs, shelled and cut into wedges  
 1/2 English cucumber, sliced  
 Salt, to taste  
 Avocado, slices, dipped in lemon water (optional)  
 Black olives (optional)

1. Make the *Louis Dressing*. Combine the ingredients and chill for at least 2 to 3 hours to blend the flavors. You can make it the day before.
2. Line four salad plates with the bibb lettuce cups. Place the shredded lettuce in each cup. If necessary, remove any bits of shell from the crab meat. Reserve the claw meat for placing on top.
3. Arrange the crab meat over the lettuce. Arrange the tomato and egg wedges and the cucumber slices in a circle around the crab. Sprinkle with a little salt.
4. If you desire, you can add the optional avocado slices and black olives. Top with the claw meat. Pour a few tablespoons of the *Louis Dressing* over each salad. Pass the remaining dressing.

### Louis Dressing

1/4 cup sour cream  
 1 cup mayonnaise  
 1/4 cup chili sauce  
 1/2 cup minced green onion  
 2 teaspoons fresh lemon juice  
 Salt and pepper, to taste

As you can see there is fiction and nonfiction, fun reads and literary gems, and it's always this way. I love to make reading lists from the books I hear about

The Evening Book Group is entirely different. I joined it just this year but most of the members have been in the group many years and the group has been in existence for as long as anyone can remember. They meet at the Saratoga Retirement Center in the fall months and at The Terraces in the spring months. About ten to fifteen women attend each month. At the June meeting the books for the following year are selected.

Everyone will read the same book and the person who suggested the book will be the discussion leader. We all sit around a big table and talk about what we did and did not like about the book. I have been amazed at the difference of opinion. I was so fascinated by the discussion of *The Memory*



*Keeper's Daughter* - some loved the book and some hated it, often for the same reasons, that now when I read the book for the next discussion I am thinking "I wonder what they will say about this one." ## End Gender Rating For All Women

One of AAUW's key priorities in the health care reform debate is an end to the discriminatory practice of gender rating. While the Senate's health care reform bill makes some steps in this area, it falls disappointingly short of the ultimate goal.

Under the House bill, insurance companies are banned from charging men and women different premiums for individually-purchased health care plans, and are also banned from charging employers different premiums based on the gender make-up of their workforce. However, the Senate bill fails to provide this protection to businesses with more than 100 workers. As a result, women working for large employers with majority female workforces, like schools, child care providers, health care facilities, and others will continue to face this discriminatory pricing. Similarly, their employers will continue to face significantly higher health care costs simply because they employ more women. As the two bills are merged

into one, contact your members of Congress now to urge them to end this discriminatory practice for all women, regardless of the size of their workplace.

Women should not be subjected to discrimination under any circumstances, let alone based on such factors as the size of their employers or the gender of their coworkers. Gender rating can result in women's monthly premiums ranging from four percent to 48 percent higher than men's, even when under identical coverage. Not only could the Senate bill's arbitrary distinction encourage employers to hire more men than women to avoid higher premiums, it could also stifle job growth for businesses near the 100-person mark that employ a higher proportion of women. In October, a group of 25 senators sent a letter urging their colleagues to end this discriminatory practice for all employers, regardless of size. Urge your members of Congress to do the same.

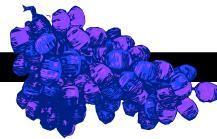
