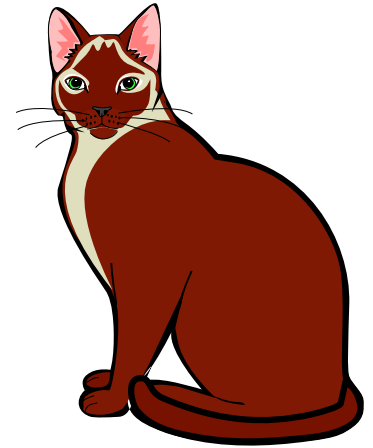
for making our Grapevine read so well, and Helen Lemmon for expanding our advertising base to defray the cost of printing and mailing the directory.

**Update on the Homeless Situation!**

Santa Clara County sent out their March 2010 Social Services Agency Employment Information. Some of the current facts may be of interest to you.

**Definitions:**

**TANF** – Temporary Assistance to Needy Families – used to be AFDC (welfare)

**CalWORKS** – CalWORKS Employment Services – the program that moves people from welfare to work

The Federal stimulus bill included a \$5 billion allocation to the TANF program nationwide. California’s share was \$1.8 billion. This helped the County create 1,124 new subsidized jobs and distribute \$1 million in emergency payments to low-income families for rent and basic utilities. These funds will expire September 30, 2010.

The County CalWORKS caseload jumped from 14,325 families on public assistance in 2009 to 16,202 as of January, 2010. The typical family consists of a single parent with one child. (70.3% of caseload).

**% below Standard in CalWORKS program by Ethnicity:**

- Latino (45%)
- African American (32.3%)
- Asian/Pacific Islander (18.8%)
- White (13.5%)

Of the clients actively engaged in employment services, 43% are employed. Of the 3,087 who are working: 760 are full-time and off cash aid 667 are full-time but do not earn enough to be self-sufficient so continue to receive supplementary cash aid, 762 are part-time and on aid.

**Self Sufficiency Standard in Santa Clara County**

The Self-Sufficiency Standard measures the actual cost of living on a county-by-county basis, accounting for different families sizes, ages of children, and local variations in costs.

**For Santa Clara County:**

- Number of households below Standard – 102,286
- % below Standard with one or more workers – 87.2%
- A family of three would need to hold almost four full-time, minimum-wage jobs to achieve self-sufficiency
- Among households below the Standard only 6.1% receive Public Assistance (TANF) and 9.7% receive Food Stamps (SNAP)

According to the report, 3 out of 10 California households lack enough income to meet their basic needs. To achieve self-sufficiency – calculating Santa Clara County monthly costs of rent, utilities, food, etc., a family of two adults and one child requires an annual income of \$58,512.

## Fresh Corn Salad

It's fresh corn season again. This recipe is wonderful but it couldn't be easier.  
MAKES: 6 servings.

- 3 cups corn kernels (from 6 ears of fresh corn)
- 1 tomato, seeded and diced
- 1 firm but ripe avocado, diced (dip in a bowl of lemon water)
- 2 scallions, thinly sliced or 2 Tbsp. red onion, diced
- 1/4 cup chopped fresh cilantro, to garnish

### LIME DRESSING:

- 2 Tbsp. fresh lime juice
- 1/2 tsp. finely minced garlic
- 3 Tbsp. olive oil
- Salt and pepper, to taste

1. In a large serving bowl, remove corn kernels from the cobs. Combine with the tomato, avocado and scallions.
2. To Make the Dressing, in a small bowl, whisk together all the dressing ingredients.
3. Combine the dressing with the salad and gently mix. Garnish with chopped cilantro right before serving.

## Work-Life Balance

### Healthy Families Act (S. 1152) Co-sponsorship

The Healthy Families Act (S. 1152) would provide accrued paid sick and safe days for many employees nationwide. It would require employers with at least 15 employees to guarantee workers seven days of paid sick leave annually.

In addition, these paid sick days could be used for treatment, recovery, and activities necessary to deal with an incidence of domestic violence.

By ensuring that hard-working Americans have access to a minimum number of paid sick days, which can also be used to care for sick dependents, this legislation would mean that employees no longer have to choose between caring for themselves or loved ones and losing much needed income.

The legislation was originally introduced by Sen. Edward M. Kennedy (D-MA) on May 21, 2009. Since Sen. Kennedy's passing, the bill has continued under the leadership

of Sens. Chris Dodd (D-CT) and Tom Harkin (D-IA). At the time the Congressional Voting Record went to press, the bill had 24 co-sponsors.

### AAUW and Our Representatives

AAUW has supported 8 Congressional issues this year as part of the Public Policy agenda. They are: the Ledbetter Pay Equity Bill, Paycheck Fairness Act, Economic Security, Paid Sick Days, DC School Voucher, Hate Crime Prevention, Sotomayer Confirmation and International Family Planning. Our representatives were mostly supportive of these issues. Barbara Boxer and Mike Honda scored 100% on these AAUW issues. Anna Eshoo scored 89% and Diane Feinstein scored 63%.

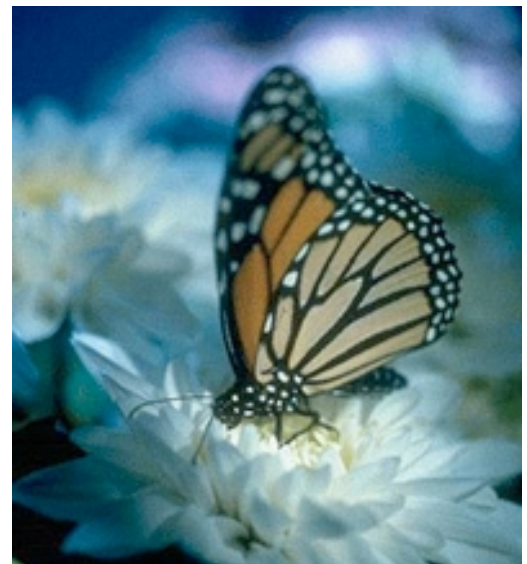

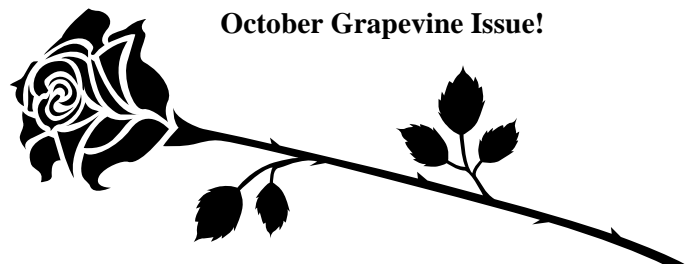

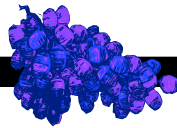

The land of Black Ridge Vineyards was planted with grapes as early as the mid-nineteenth century during the California wine boom. Replanted with prune trees during Prohibition, and later converted into a Christmas tree farm, Black Ridge Vineyard partners, Jim Landes and Fred Faltersack returned the land to its roots by replanting grapes shortly after they purchased the property in 1999. Black Ridge Vineyards produces 100% estate-grown wines.

### Directions from San Jose/ Los Gatos:

Take the Bear Creek/Black Road exit off Highway 17. Go straight at the stop sign and continue on Montevina Road a few hundred feet to Black Road on your left. Turn left and go about 1/2 mile up Black Road to Black Ridge Vineyards which will be on the left hand side (*the second stone entrance with two gates*). The main entrance is the gate on the left.
