
It's Time to Renew Your Membership


An Interest in Reviving the “Independent Women” Group

Meet Our Three Local Scholarship Recipients for 2013

Los Gatos-Saratoga AAUW gives scholarships to three remarkable and inspiring recipients.

Shannon Ferreira plans to change the world. While still a high school student, she has maintained a 4.0 grade point average student in the Middle College program at West Valley College, an advanced program in which juniors and seniors take both high school and college courses. She has already earned 40 units of college credit which will transfer to Cal Poly with a major in Mechanical Engineering.

Her goal is to work in renewable energy and harness the power of the natural elements to create new, more effective forms of sustainable energy. She realizes the importance of the math classes she has taken but particularly enjoys her physics classes. In her spare time she played on a club soccer team for nine years, learning the value of teamwork and communication, as well as different kinds of leadership styles. She has been a volunteer at Adobe Animal Hospital, and volun-

teers to help the elderly as well as young students in the area where she lives.

Diem-Phuong or "Tina" Nguyen loves helping people, especially those in need. She grew up in Vietnam and in 2008 immigrated to the US with her family as a high school student. She experienced racism and discrimination at school and felt very isolated and alone. She turned to her studies and realized how much she enjoyed them, earning a 4.0 GPA.

Working at a fast food restaurant helped her improve her English and her interpersonal skills and she has become involved in the tutoring program at West Valley College. Occasionally she helps translate for other Vietnamese students. Along with her studies, she takes care of her mother since her father died about a year ago, and also has a one-year-old daughter. The course which has had the most impact for Tina is biology, which opens many mysteries about human health, and she has maintained a 3.7 GPA at West Valley. She plans to

enroll this fall in the Nursing program at San Jose State University.

Nhi Nguyen has learned a lot from the flea market. When her family lived in Vietnam, they thought of America as a shiny heaven with luxurious furniture, classy clothes, high technology and too much money to spend. But Nhi knows the other side of America, that of the flea market where people trade old stuff, negotiate, argue and distrust.

Her parents work very hard and sacrificed much to come to a foreign country with big hopes; she plans to honor their commitment by becoming a physician who will cure thousands of sick people in her lifetime. First she will get her degree in biochemistry and molecular biology at UC Davis, then apply for medical school. She loves her science and mathematics classes and is a math tutor at West Valley College and has earned a 3.8 GPA. When she is not busy with school, she likes to play the keyboard which she bought at the flea market.

What Happened at the Legal Advocacy Fund Luncheon?

Jennifer Reisch was the guest speaker at the AAUW CA Legal Advocacy Fund Luncheon on March 16, 2013.

Jennifer is the Legal Director for Equal Rights Advocates, a national nonprofit law firm dedicated to protecting and advancing the rights of women and girls. She spoke about the Dukes vs. Wal-Mart case and representing Betty Dukes and the women of Wal-Mart.

Did you know that Wal-Mart is the biggest employer in the US? Or that 2/3 of the employees are women and 1/3 are men, yet management is 2/3 men and 1/3 women? According to Jennifer, this happened because Wal-Mart has a history of not posting management jobs and has no application forms for management job openings. They also require that if you do apply for a management position, you must agree to be transferred in 48 hours. Few women or men could agree to move this fast. Often managers tend to promote people they know and, since Wal-Mart didn't

have an organized Human Resources Department, it was easy to promote someone they knew rather than promote from a fair unbiased position.

Jennifer said, "*Betty Dukes is a strong person and continues to work at Wal-Mart in Pittsburg, CA. It is important that she and the other women continue to work at Wal-Mart while they argue their case in Federal court in San Francisco.*" There have been many cases filed against Wal-Mart throughout the United States.

Update on Committee on Homeless Women and Children

The Woman's Foundation of California focuses on empowering women to achieve economic security. Their study "*Falling Behind: The Impact of the Great Recession on California's Women and their Families*", 2012 summarized seven areas of concern.

1. The gap between California's rich and poor is the seventh widest in the nation.
2. Single mothers were hardest-hit by the recession and recent budget cuts.
3. Older Women remained in the work force longer but were more likely to live in poverty.
4. Cuts to state childcare and preschool programs hindered the ability of low-income parents to keep their jobs or get back into the work force in the aftermath of the recession.
5. Women have been dispassionately affected by cuts to essential health care services for low-income Californians.
6. Cuts to assistance to older women and women with disabilities have compressed their ability to afford necessities such as housing and groceries.
7. Budget cuts have reduced access to higher education for women seeking to gain the skills they need to obtain higher-wage jobs in a highly competitive job market.

The Governor's proposed 2012-2-13 budget will further weaken programs that California Women depend on, leaving cash-strapped state and local governments ill-equipped to make up for the loss of federal funds.



Vote Today in the AAUW California 2013 Elections

This is a reminder that the AAUW California is currently conducting an electronic election for officers. If you have not participated yet, we hope you will cast your vote today. **This state election is different from the national AAUW election which is also running at this time.**

We are voting for two officers this year, **President Elect**, a new position that will serve as vice president for one year before assuming the presidency for two more years, and **Chief Financial Officer**.

In addition we will elect enough directors to complete the board. Currently there are eight director vacancies. If the proposed bylaws amendment to reduce the size of the board (see below) passes, the four top vote-getting candidates will become directors.

Other ballot items are the proposed Public Policy Priorities for 2013-15, a bylaws amendment to reduce the size of our Board of Directors, and a

proposal to increase our annual membership dues.

The three-week election period is currently open and ends on May 11, 2013. Links to each candidate's Information Form and to the Public Policy Priorities are available on the ballot page.


