## History of San Jose Taiko

Since 1973, *San Jose Taiko* (SJT) has been mesmerizing audiences with the powerful, spellbinding, and propulsive sounds of the taiko. Inspired by traditional Japanese drumming, SJT performers express the beauty and harmony of the human spirit through the voice of the taiko as they strive to create new dimensions in Asian American movement and music.

Under the artistic direction of Roy & PJ Hirabayashi, performance and expression are predicated upon a profound respect for each member of the group. The spirit and essence of both rehearsal and performance require physical endurance, with running and exercise required of all members during practice sessions. All compositions performed by SJT are written or arranged by members of the group. Composing, choreographing, designing and producing costumes, and handcrafting of the drums are part of the holistic process in which all

members participate. Through this singleness of mind and spirit, harmony is achieved and the music rings with unity and clarity.

SJT has broadened this historical art form into a style that joins the traditional rhythms of Japanese drumming with other world rhythms, including African, Balinese, Brazilian, Latin, and jazz, bridging many styles, while still resonating with the Asian soul in America.

SJT has been recognized for its artistic and managerial excellence by the Advancement Program from the National Endowment for the Arts, the Multicultural Advancement Program from the California Arts Council, Meet The Composer International Creative Collaborations, the Rockefeller Foundation, the Knight Foundation, the Nathan Cummings Foundation, and the Chevron Award for Excellence.

### Updates, Highlights, and Honors

The Board gave Mary Ellen and Barbara a round of applause in appreciation for their representation.
- Program VP, Mary Surginer, reported that everything is in place for our first General Meeting on Saturday, September 12<sup>th</sup> at The

Terraces-Los Gatos. "The Zingers" singing group performed for us. The Interest Group chairs arrived early to set up their tables. The brunch was ready as well.

- Geri Williams, EF VP, reported that the National Branch has notified her that EF has changed its name to AAUW Funds. Geri also announced that both the Author's Luncheon plans and the April Potluck plans, which Kathy Cusick is chairing, are on target.
- The Local Scholarship Fund-raiser chaired by Virginia Turner has been set for October 25<sup>th</sup> at Sacred Heart's Geary Hall. San Jose Taiko Drums will be the entertainers. Tickets are selling for \$15 to benefit West Valley College women.
- Betty Maminski, LAF VP, reported that she was able to add \$695 in donations to the dues collected this year.
- Louise Quenon reported that the bridge groups will handle the refreshments.
- Nancy Hobbs reported that Marie Wolbach, founder of Tech Trek, would be our General Meeting speaker on Saturday. The six student recipients who attended this summer's Tech Trek also attended and shared their experiences.
- Dianne Priest reported that the Directory is at the printers and will be ready for us at the General Meeting on Saturday morning. The Board gave a round of applause to Dianne.
- Gail Pedersen accepted kudos for her first Grapevine. Again there was a round of applause for Gail and Courtney Duncan, who started a

new job and was unable to attend the board meeting.

- Jean Wenberg reported that the Directories that are not picked up Saturday will be mailed by her committee.
- Margaret Bard, Interest Group Coordinator, reported that she plans to attend a group at a time and write about it for the Grapevine.

## A Picture of Homelessness Today

The following are the results of a survey done on January 26 and 27, 2009 in Santa Clara county:

1. 7,086 are homeless on any given night. This is down 2% from 7,202 in 2007.
2. Of the 7,086 homeless, 4,983 are unsheltered.
3. 12,377 were homeless in the last 12 months. This is down 31% from 18,056 in 2007.
4. 2,270 are chronically homeless, up 35% from 2007.

These statistics may have changed since the survey in January 2009 as many more people have lost their jobs since that time. Homelessness costs \$62,000 per person/per year. The cost of emergency care/ambulance is very high. The current shift in the approach to aid the homeless is housing as a priority and then following up with other resources. Working on this principle is the agency, “One-Stop-Shop” — one of which is housed at the Georgia Travis Center.

The members of our Committee are frequently asked what items the Georgia Travis Center can use.

The following items are always appreciated:

- Toiletries – shampoos, soaps, hygiene items, and especially the motel/hotel shampoos, conditioners, toothbrushes, toothpaste and soaps.
- Men's, women's, children's clothing – They also provide a wardrobe to women beginning new employment.
- Household items to help set up new housing - blankets, linens, kitchen equipment.

The Georgia Travis Center (GTC) is on the corner of 7th St. and Commercial Ave. in San Jose at the InnVision Shelter.

## Recipe

### Lavonne's Ham & Cheddar Strata

I have been preparing this dish for various occasions (mostly brunches) during the past forty years. It is an easy entertaining dish since you put it together the night before and refrigerate it. Substitute turkey or sausage for the ham. To make a vegetarian version, leave out the ham and use mushrooms or spinach instead. *To make a smaller amount, you can cut the ingredients in half and use a 9x9-inch baking pan.*

In a bowl, beat to combine the eggs, milk, mustard, garlic salt and white pepper. Pour over the layered ingredients. Cover and refrigerate overnight.</li> <li>4. The next day, preheat the oven to 350° F. Bake, uncovered, for 60 minutes. It will come out of the oven like a puffy egg dish. Serve hot or warm.</li> </ol> |

## AAUW's Advocacy of Health Care Reform

While there is no shortage of proposals for how health care reform should be achieved, AAUW's emphasis is not on pushing one proposal over another, but instead ensuring that whichever program ultimately emerges provides access to quality and affordable health care for all Americans. AAUW's position is that everyone is entitled to health care that is high-quality, affordable, and easily accessible.

Without health care reform, insurance companies could continue the discriminatory practice of gender rating, and women could continue to pay monthly premiums ranging from four percent to 48 percent higher for individually-purchased health care plans than men.

### First Key Element.

Without health care reform, insurance coverage for basic reproductive health care services for women could continue to be denied.

Without health care reform, access to and coverage of preventive services like screenings, immunizations, and educational material may not be covered or expanded, and women could continue to die of preventable and treatable diseases.

As debate in congress picks up steam, AAUW believes we must advocate to our members of Congress. Tell

them that these **Three Key Elements** must be included in any final health care reform legislation. *Now, tell a friend to do the same.*

Health care is intrinsically tied to economic security; this is particularly true for women, who earn less than men on average and use more health care services than men do. These two factors—less income and more costs—mean women face a high-level of health care insecurity. Health care reform is necessary now more than ever, and it must focus on the need for access and affordability in a way that is equitable to women.
