Letter from the Leadership Team



What is ISPF and what does it do?

You may have already responded to a letter from Louise Quenon, our branch Treasurer, asking for your financial support for our three local philanthropic projects: the Committee on Homeless Women and Children, Local Scholarships, and Tech Trek. Donations are tax-deductible, and your check should be made payable to ISPF – AAUW.

What is ISPF? The abbreviation stands for **Interbranch Special Projects Foundation**, a non-profit charitable organization which is used by the AAUW branches within Santa Clara County so that donations for various projects can be tax-exempt for the donor as specified by federal law. All of the branch projects within ISPF are covered by one tax return which greatly simplifies the administrative work that would otherwise be required for the separate branches.

Our own **Nancy Hobbs** organized ISPF in 1988 and served as its president for 18 years. Faith Schmidt was the first secretary and **Jan Leyse** the first treasurer. Board members came from Gilroy, Los Altos, Morgan Hill, San Jose and Sunnyvale.

The first approved ISPF project was our Committee on Homeless Women and Children which raised money for bus passes to be given to families staying at the family shelter and bought a VCR for the Family Living Center. In the second year **Kay Eshleman** became the Treasurer, and two new projects were added – Project Homeless by the San Jose branch and The Treasure Box by the Gilroy branch. **Nancy Christensen** soon became the ISPF Secretary and served with Nancy and Kay for many years. Early records were kept on ledger paper and tax returns were handwritten!

Los Gatos-Saratoga started another early program, Local Scholarships in 1993, and sent a girl from Redwood Middle School to the first Tech Trek camp in 1998.

In 2006, Nancy Hobbs, Kay Eshleman and Nancy Christensen decided to “retire” after almost two decades of running ISPF and turned over administrative responsibility to members of the San Jose branch: Gloria Leonard as President, Brenda



Ladewig as Secretary and Zee Del Fiugo as Treasurer. In turn they retired in 2012, and the current officers are Carol O'Hare, President (Morgan Hill), Elena Anderson, Secretary (Morgan Hill), and **Virginia Turner**, Treasurer (Los Gatos-Saratoga). Each branch with ISPF projects has a representative on the Board of Directors.

At this time 11 projects are being operated by Gilroy, Los Gatos-Saratoga, Morgan Hill, San Jose and Sunnyvale-Cupertino branches, with an additional project for Tech Trek still supervised by Tech Trek founder Marie Wolbach (Palo Alto branch). In the fiscal year that ended June 30, 2016, ISPF raised **over \$200,000** for projects to benefit women and girls within our local communities. A total of 26 scholarships were awarded, 32 girls were sent to Tech Trek, 1,384 gift bags were given to local low-income teenagers, and countless women and girls were helped both directly and indirectly through various agencies and programs.

Public Policy Update

- *“Women’s Rights Are Human Rights”* AAUW will have an official delegation to the Women’s March on Washington on January 21 in Washington, DC. Other marches will be held around the country, including San Jose.
- The U.S. House of Representatives passed the bipartisan **Women, Peace and Security Act (WPS Act)**, which would ensure that women’s voices are heard when decisions about conflict prevention are made. Research has shown that women’s involvement in peace processes leads to a substantial probability of an agreement lasting longer. Yet women currently make up only 10% of negotiators in peace agreements. Contact your senator now to urge them to pass this bill.
- Recently the Washington, D.C. Council heard testimony on a bill that would bar employers from using prior salary of applicants during the interview process. Kate Nielson, AAUW’s state policy analyst, testified in support of this bill. AAUW suggested strengthening the bill by adding a provision requiring job postings to include a salary range.
- The bipartisan Congressional Commission on the American Museum of Women’s History presented a proposal for a new Smithsonian museum dedicated to women’s history.



Legal Advocacy Fund – GOSSET v. LASCH

Title VII of the Civil Rights Act of 1964 prohibits discrimination in employment on the basis of sex, race, color, national origin and religion. Sexual harassment is a form of discrimination. Nathalie Gosset, an AAUW member & active Tech Trek supporter, was hired, in 2003 by the Alfred E. Mann Institute at University of Southern California as a senior engineering manager.

She was promoted to senior director of marketing and technology evaluation, a position directly below the executive director, Jonathan Lasch. Gosset claimed she was subjected to ongoing sexual harassment by her boss. *“He would talk about what happened between the bed sheets the night before. You know, sexual positions, and how he performed or didn’t perform.”* Gosset reported the harassment, but claims that her complaints were disregarded. She states that her duties were reassigned and reprimands were issued. In 2015, she was terminated, as was the full four-year scholarship that had been awarded her daughter. Gosset has since filed an arbitration demand. Since the matter is in arbitration and not a federal case, AAUW cannot offer financial support at this time. However, because sexual harassment is a core issue, AAUW dedicates their moral support.

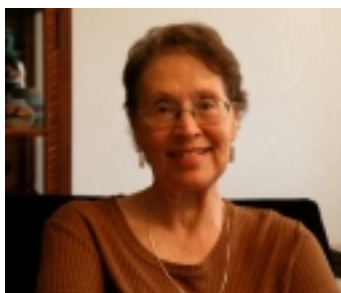

Janet Dawson was born in Oklahoma and grew up in Colorado. With a journalism degree from the University of Colorado, she worked as a newspaper reporter. Next she joined the Navy. An enlisted journalist, she wrote news and features in public affairs offices in Guam and Pensacola, FL. As an officer, her duties took her to the San Francisco Bay Area, where she lives in Alameda. After leaving the Navy, Dawson worked in the legal field and at the University of California.

Now retired, she writes full time. Janet has a master's degree in history from California State University East Bay and can't think of anything she wants to study enough to go back to grad school. She enjoys gardening, cats, and climbing around on trains.

In elementary school, Janet wrote mysteries in long-hand on lined binder paper, influenced by those blue-backed Nancy Drew books she devoured. She has written eleven novels featuring Oakland private investigator Jeri Howard. Her first book, *Kindred Crimes*, won the St. Martin's Press/Private Eye Writers of America contest for Best Private Eye Novel, and was nominated for Shamus, Anthony and Macavity awards. Other books include *Till the Old Men Die*, *Take a Number*, and her latest *Cold Trail*. She wrote a suspense novel, *What You Wish For*, and a historical mystery set on a train, *Death Rides the Zephyr*.

Dawson is a longtime member of Mystery Writers of America and chair of the Edgar Allan Poe awards. She also belongs to Sisters in Crime.

Shelly lives in the Santa Cruz mountains with her husband, John, and two big lovable dogs (*Tyson and Reba*), three kick-ass barn cats (*Caesar, Xena, and Loki*), and an adored indoor princess cat (*Scout*). *THE MOMENT OF EVERYTHING* is her first novel.

Anne Heffron

Anne Heffron was born in Manhattan in 1964 to a young college student who gave her up for adoption. Adoption can be tricky. It's a wonderful thing to be chosen, to be brought up by loving parents, but in order for this to happen, there has to be an initial abandonment, and this loss can settle like a seed of unease in the adopted person, quite possibly affecting the entirety of his or her life.

Anne, who would be adopted at ten weeks old, embarked fifty-one years later on a journey to Manhattan to find the roots of her story and to tell that story. This was not the story that began "*The day we got you.*" This journey is the subject of "*You Don't Look Adopted*", an account of the perils and blessings of adoption. This book is an intimate look at what it means for an adopted person to live in the world as someone who was both chosen and given away.

Before turning to memoir, Anne co-wrote the film "*Phantom Halo*" with her writing partner, Antonia Bogdanovich. The film "*Phantom Halo*" was first shown at the 2015 Austin Film Festival and won Best Picture at the 2015 New York International Film Festival. She and Antonia currently have a screenplay, "*The Rabbit Will Die*" in development. When she isn't writing, she's either doing laundry, hiking (which really means just walking on a dusty road), watching her daughter play field hockey, or sitting in the back row of a movie theater or looking for adventure.

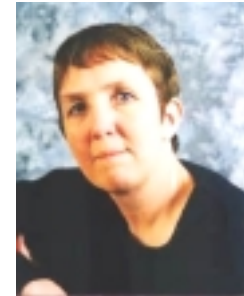

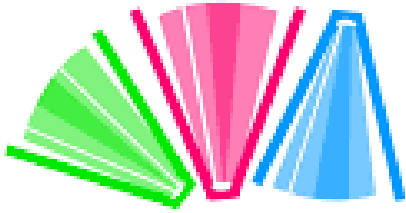

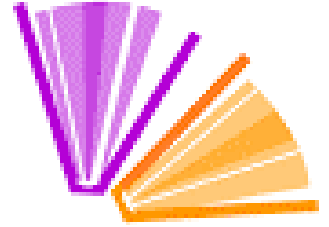
