


Coming This Summer!

Year Around Hikes and Walks Check out those scheduled for this Summer

Every second and fourth Thursday of the month, rain or shine, a group of us fresh air and exercise enthusiasts roam the beautiful hills and valleys of our area. Join us for outdoor adventure and camaraderie!


The second Thursday of the month we bring our lunch and plan a full day’s adventure—usually back by 4. The fourth Thursday is a “Back-by-Noon”, “Show and Go” hikes that are nearby and unplanned. Often we end with coffee and chatter. Hikes are usually from 4 to 5 miles long. If you think that is too difficult, you are encouraged to bring a companion of your speed and go a lesser distance.

Each summer we plan the trips for the year and print a schedule, which you can

get from your leaders. Adventures include wildflower walks, stream hopping, fabulous views, waterfalls, shade on hot days, cool coastal walks, and ups and downs in the many beautiful, nearby open spaces. Often we include an eating adventure like pies, berries or fish and chips. Once a year we do an urban exploration hike in San Francisco. Every 2 months we do a trail clean-up and reward ourselves with a nice lunch.

Details of the AAUW Funds Awards Potluck Luncheon

The speaker for our annual AAUW Funds Potluck Luncheon was Meredith May, who is the recipient of an AAUW Career Change Grant. Currently she is a journalist working at the *San Francisco Chronicle*, doing interviews and writing articles once a month in the Sunday Magazine section.

When she started at the *Chronicle*, she was expected to use the crisp journalistic style of newspaper writing, but she really wanted to write feature stories, to write about how people think and feel about their world. This led to her decision to enroll in the Goucher College (in Baltimore) program for writing creative non-fiction, to learn to write her memoirs and end up with a book, as well as get an MFA. Her AAUW Grant has helped her to reach that goal.

Meredith gave us a brief description of what is involved in this long-distance college course: each semester the student is obligated to write a certain number of pages, destined to be part of a book, and present them, via Skype, to a panel that includes a professor and other students for critiquing. Retreats of 4 days in winter, and a longer one in summer are spent at Goucher for more intense critiques.

Her memoir will be about growing up with her grandparents in Carmel Valley, and leaning about raising honeybees, which is what her grandfather did. She had a computer movie presentation – this was a first for her — about her grandfather, who had what he called his Honey Bus, a WWII army bus, parked in the back yard, where his bee hives were. We were shown how he tended his bees, and “invented” some of his mechanical aids.

She’s involved with the *Chronicle*’s two rooftop beehives, whose bees pollinate the Food Department’s rooftop garden. The question was asked where do the bees get pollen in this downtown urban setting, and Meredith said that the bees fly in a 3-mile radius, which includes parks and private gardens.

Meredith will be writing the “Honey-bee Chronicles” in the Sunday *Chronicle* each month, the first of which just happened to have been in the previous Sunday’s (24 April) Home & Garden section of the paper. She also showed us the bee suit that she wears – not the full gear, just the top, with gloves and the hat with the face-veil.

There was a short Q&A session, after which Meredith read from the first

chapter of her book, describing her first experience with her grandfather’s bees, and beginning to learn how to keep cool around bees. Maybe she will come to our Authors’ Luncheon when her book is finished and published. We will enjoy that!

In the rest of the afternoon’s program, Lavonne Marafino introduced the slate of next year’s officers, along with the explanation that since the Nominating Committee was unable to persuade anyone to take the President and President-elect positions, different committees will be in charge of each month’s program.

Nancy Hobbs introduced three of the eight graders who had gone to last summer’s Tech Trek camp at Stanford, and each girl spoke of her experiences, which they were very enthusiastic about.

Virginia Turner introduced two local scholarship recipients, who thanked AAUW for the opportunity to further their education.

And lastly, the Named Gift Honorees were presented: Geri Williams (who was traveling and not present) by Lavonne Marafino, and Mary Surginer by Gail Pedersen.





Meet This Year's Local Scholarship Recipients

The Local Scholarship Committee is pleased to award \$1,000 scholarships to three amazing women who are finishing their work at West Valley College and transitioning to four-year colleges or universities with a major in math or science or a related field. The Committee was truly impressed by everyone's academic records and personal essays and only wished that we could have given scholarships to all of our applicants.

In her childhood **Sonia Ghandi** used to dissect insects and reptiles out of curiosity about what was going on inside their bodies. In middle school she saw interesting organisms under a microscope and thought she might want to work in a medical laboratory. But her real passion may be agriculture. Her father showed Sonia how to plant and nurture trees on their farm, and when she came to America from Iran she worked as an intern in the City of San Jose's Environmental Services Department. One of her supervisors there said that "*Sonia was by far one of the most impressive participants in the program.*" She became an honor student at West Valley College with a 3.56 GPA. She will transfer this fall to either UC Berkeley or UC Davis to major in Biological Sciences. Her plan is to pursue a Ph.D. in Agricultural Biotechnology so that she can create or improve plant species to solve today's urgent environmental issues.

Capella Kerst has a wide range of interests—teaching swimming to young children, ballroom dance, playing golf, and tutoring at the West Valley College Math Resource Center to help meet basic expenses. She serves as a youth leader at her parish, was on the staff for *The Norseman* (WVC newspaper) and was the treasurer of the Alpha Gamma Sigma



honors society. As an undergraduate full-time student with a math major and physics minor, she maintains a 4.0 GPA. One of her math instructors reports that Capella "*never received less than a perfect score on any of her homework assignments or quizzes.*" She greatly enjoyed taking physics for the last four years, and wants to pursue a research career in physics. She has been accepted to Cal Poly and is pending acceptance at UCLA, Stanford, Williams and Wellesley.

Mahvash Sadeghi came to the United States in 2002 and married her Iranian-American fiance, who unfortunately died of cancer the following year. She thought about returning to Iran but decided to stay and make this country her home. She worked in different places such as fast food restaurants, where she worked hard and became a manager. When she realized she expected more of herself, she enrolled in ESL to improve her English ability, and started taking pre-nursing courses. One of her instructors noted "*her natural brilliance coupled with sheer hard work is an unbeatable combination.*" Her goal is to become an educated, active nurse in order to help patients as she saw the nurses at Kaiser helping her husband. She maintains a 3.9 GPA and has been accepted to San Jose State University for this fall.

Truth About Planned Parenthood Funding and Services

Recently, Congress has increased threats to stop funding Planned Parenthood. The right wing is demanding that Planned Parenthood lose its federal financing because they do abortions. The *“Truth”* is that the abortions that are performed by Planned Parenthood are not and have never been supported with federal funding—*it is against the law*. Many years ago I wrote an article for the *Grapevine*, *“And You Thought it was an Abortion Clinic”*.

I wonder if you know that abortions make up 3% of the services that Planned Parenthood provides. Federal funds provide for paps tests, breast exams and mammogram, and family planning—*one of the best ways to decrease abortions*. Yes, if you show up with a sprained ankle they will assist you with that too.

Remember that Planned Parenthood is providing necessary medical and counseling services that you and I take for granted. If you do not have health insurance, those services will be provided elsewhere at a very high rate—probably not affordable for most women and families. Just another case of *“you can't believe everything you hear or read”*. Let your Congress person, know that AAUW and you support continued financing for Planned Parenthood.

LAF Updates

Mansourian Case Goes to Trial

In their lawsuit, *Mansourian v. Regents of the University of California*, Arezou Mansourian and other former members of the University of California, Davis's women's wrestling team say that the university discriminated against them in violation of Title IX. Over the last decade, their case has gone through different courts to determine whether or not there was sufficient notice of the discrimination, not whether or not discrimination occurred. On May 23 they will at last have a hearing on the merits of the case. The case never would have reached this point without AAUW's support.

The trial will be held in federal court at 501 I St., Sacramento, California. It starts at 1:30 p.m. on May 23 in the courtroom of Judge Damrell and will continue beginning at 9 a.m. May 24–26, May 30–June 2, and June 6–9.

Decision in Harris v. Baltimore

In early May, the U.S. Court of Appeals for the 4th Circuit issued a ruling in the case of Lynette Harris, an electrician with the city of Baltimore who had sued for sexual harassment after being subjected to a work environment with sexually explicit pictures and language. AAUW signed onto an amicus brief supporting Harris's case. The circuit court found that there was sufficient evidence of harassment, but it still affirmed the granting of summary judgment for the city on Harris's failure to promote her claim.


