

Meet the Branch Leadership Team

Gail Pedersen (*Membership Treasurer*) comes from a large family with 5 children – three girls and two boys (with Gail, the middle child). I was born and lived in northwest Montana until second grade when my family moved to California. I went to college locally – first at West Valley College (WVC) and next transferring to San Jose State University to earn a B.S. in Interior Design.

I worked as a facilities and design consultant but by the late 1980s I found that I needed computer skills. I had graduated from SJSU just as the first Apple personal computer hit the market.

I returned part-time to WVC to learn computer office application and digital media / design skills. I earned a number of degrees and certificated in areas of Graphic Design, Communications, Office Procedures and Office and Graphic Applications. I started working at WVC: first as a student computer lab assistant, then part-time teaching Computer Applications and Digital Media classes while also working for the West Valley-Mission College district in the staff development program.

A move to the High Tech industry in the late 1990s completed my career shift. I continued to teach at WVC and also worked as a marketing assistant, graphic designer, and office coordinator until the 2005 layoffs. Since then I have been caring for my oldest sister, Ann, (*who has complete renal failure*) and working as a business assistant, Graphic Designer and sometimes a general "Jill" of all trades.

I joined Los Gatos-Saratoga AAUW in 2008-09 as the Grapevine newsletter editor. My role expanded to include many branch communications jobs (*the newsletter, PLUS – the directory, new members recruitment, membership treasurer, and updating the website and stationery with the new AAUW graphic look in 2013-14*).

I support the AAUW mission and enjoy helping to improve communications throughout the branch.



Los Gatos-Saratoga AAUW: The 1990s

The branch celebrated its 50th anniversary with a reenactment of our 50-year history, including songs performed by our own "Andrews Sisters" and a 1940's tableau depicting the valuable contribution of women to the war effort through service in the armed forces, the Red Cross, the workplace, and volunteer organizations.

Georgia Travis was appointed to the Santa Clara County Commission on Social services. **Margaret Brackett** and **Nancy Hobbs** received the Santa Clara County Human Relations Award. Two members were named Saratoga Citizen of the Year – **Mary Jeanne Fenn** (1998) and **Marlene Duffin** (1999).

In 1992 AAUW released its research report "How Schools Short-change Girls" which prompted Marie Wolbach of the Palo Alto branch to seek funding for projects that AAUW could perform locally to engage girls in science, technology, engineering and math (STEM). In the spring of 1997, AAUW of California received a Community Action Grant from the national AAUW office, and Tech Trek began in the summer of 1998 with 151 California girls attending the first camp.

The Local Scholarship Committee, organized in 1992, inaugurated the annual Chinese New Year Dinner as its fundraiser, held around the time of the Lunar New Year and featuring a variety of speakers about some aspect of Chinese history and culture. The Committee on Homeless Women and Children continued to hold an English Tea as their fundraiser each year; members provided the

food and brought their finest china dishes for the table settings. We held several House Tours and we sold entertainment coupon books to raise money for the Education Foundation.

Monthly programs featured a wide variety of topics – the emerging European woman, women in the arts, teaching astronomy to teachers, the North American Free Trade Agreement, women's health issues, cultural diversity, stress management and coping, the juvenile justice system, the rewards of rituals. Our Interest Groups included both morning and evening book review groups, bridge, film buffs, Friday matinee, Great Decisions, hikes and walks, let's do lunch, low-fat gourmet, sights and sounds, supper club, travel, and the vintage sippers.

We earned the Five Star Award at the 1997-98 state convention with our excellence in Community Action, Public Policy, Education Foundation, Legal Advocacy, and Visibility.

Review Our Updated Bylaws

Amendments to Branch Bylaws

Following the national and state AAUW meetings last year, there were a number of minor changes that were required in our branch Bylaws to bring them into compliance. Since these are **mandatory changes**, there was no need for a branch vote and Board approval at our monthly board meeting on February 1, 2016.

In reviewing our Bylaws, the state Bylaws Chair also suggested a few other **optional amendments** which the Board has reviewed and recommends for branch approval. Some amendments would eliminate duplicate language within the Bylaws: When dues are payable, composition of the Executive Committee, the role of the Parliamentarian, duties of the Secretary, filing of annual reports, and recording votes of the Executive Committee. Other proposed amendments would provide more flexibility in when to hold the

Annual Meeting (*currently they state that it will be in April*) and how to notify members about business meetings to include email, mail, the Directory and our newsletter.

Another proposed amendment would clarify voting rights for **co-chairs sharing one position**. The issue with co-chairs is that California state laws say that incorporated branches (*we incorporated in 1960*) must give each officer a vote, so co-officers would each have a vote on the Board which would give those positions double voting power. After extensive discussion the Board felt that we definitely do need to comply with state laws and should change the Bylaws accordingly. If we do have two people sharing one position, our Policies will define that any officer may have (*non-voting*) assistants to help fulfill the duties of that position.

BYLAWS OF THE AMERICAN ASSOCIATION OF UNIVERSITY WOMEN LOS GATOS-SARATOGA, INC., CALIFORNIA, BRANCH

ARTICLE IV. MEMBERSHIP AND DUES

Section 5. Dues.

- d. ~~Dues are payable annually on or before July 1.~~ *[Rationale: The details of when/how dues are collected belong in branch policy, not the bylaws. The bylaws establish that the fiscal year begins July 1 in Article X, Section 1, so there is no need to repeat it here.]*

ARTICLE VI. OFFICERS

Section 1. Officers.

- a. The elected officers shall be a President, President Elect; vice presidents for Program, Membership, AAUW Funds, Legal Advocacy Fund, and Finance; and Secretary. ~~These officers shall comprise the Executive Committee.~~ *[Rationale: Article VIII defines the Executive Committee, so it is duplicative to repeat it here.]*
- f. ~~Each position may be filled by an officer or co-officers.~~ *[Rationale: CA state laws says that incorporated branches must give every officer a vote, so co-officers would each have a vote on the board. This would give those positions double voting power. Instead, policy could be written to authorize each position to have a non-voting assistant or committee if desired.]*

Section 2. Duties.

- f. ~~All officers shall submit an annual written report to the President.~~ *[Rationale: This practice no longer takes place.]*

ARTICLE VII. BOARD OF DIRECTORS

Section 4. Minutes. Minutes shall be recorded of all meetings of the Board of Directors and Membership Business meetings. Minutes must be kept available for any Board member to review. *[Rationale: Article VI, Section 2-d already established that the Secretary takes minutes at all meetings (board, membership, special meetings) and makes the minutes available upon request, making this section duplicative.]*

Section 5. Quorum. The quorum of the Board shall be a majority of its voting members. ~~Co-officers shall be considered as one voting member.~~ *[Rationale: CA law prohibits sharing votes for an incorporated branch.]*

ARTICLE VIII. EXECUTIVE COMMITTEE

Section 5. Voting Between Meetings. Between meetings of the Board of Directors, a written or electronic vote of the Executive Committee may be taken at the request of the President on any question, provided every member of the Executive Committee shall have an opportunity to vote upon the question submitted. If a majority shall vote on any question so submitted, the vote shall be counted and shall have the same effect as if cast at an Executive Committee meeting. **The result of the vote shall be recorded in the minutes of the next Board meeting.** *[Rationale: Clarifies how these votes would appear in branch records.]*

ARTICLE XI. MEETINGS

Section 1. Annual Meeting. The branch shall hold an annual meeting to conduct the business of the branch including but not limited to hearing officers' reports, reviewing the budget, electing officers, establishing dues, amending bylaws, and giving directions to the Board. The general membership meeting held **between the months of March and May** ~~in April~~ shall be designated the Annual Meeting, the exact date, time and place to be determined by the Board. *[Rationale: Allows more flexibility in scheduling the annual meeting, and deletes the end of the sentence which duplicates what is in Section 2.]*

Section 2. Membership Meetings. The branch shall hold at least three (3) business meetings during the fiscal year. The Board shall determine the time and place for these meetings ~~and publish the dates, times, and location in the Membership Directory and Grapevine newsletter.~~ *[Rationale: Section 4 already requires advance notice of all meetings, and the bylaws should allow the board to do so in a variety methods (including email or US mail outside of the newsletter), rather than giving this level of specificity.]*

Section 5. Voting. Voting members entitled to vote at any meeting of members or by ballot **shall be all** those voting members in good standing as of the election ~~meeting~~ notice. *[Rationale: Inserts missing words, and changes "election" to "meeting" to include voting of other types in addition to the branch elections at the annual meeting.]*

Section 6. The Quorum. The quorum shall be ten percent (10%) of the branch membership. ~~Eligible member voters are those who have paid their dues 24 hours before the meeting when the vote takes place. A majority of those voting is required to approve a motion.~~ *[Rationale: The 2nd sentence conflicts with Section 5, which requires the member to have paid dues by the time of the meeting NOTICE, which would be at least 7 days prior to the meeting. The 3rd sentence is already covered by Article XIV, which assures the use of standard parliamentary procedure such as this.]*

ARTICLE XVI. AMENDMENTS TO THE BYLAWS

Section 1. Mandated Amendments. Amendments required by AAUW or the state to bring branch bylaws into conformity shall **only not** require a vote of the branch members ~~as required by state law or branch Articles of Incorporation.~~ *[Rationale: The articles of incorporation do not require a membership vote for mandatory amendments, so this now makes that clear.]*
