## Women in Leadership

### Our Past – Global Women's Leadership (GWL)

Our March 2011 program featured the topic: **Women's Strategic Role in Addressing Global Issues**. Tanya Bunger, our speaker, and some of her students spoke about the Global Women's Leadership (check out [www.gwln.org](http://www.gwln.org)) which is sponsored by Leavey School of Business at the University of Santa Clara. Their program goals: "Women leaders ARE the future, and women's leadership capacity building is a high level strategy to accelerate global change."

Success is visible as women address critical issues to meet basic needs. Women are working diligently in Malawi, India, Mexico, and world-wide. Women leaders are supported in five areas: (1) economic participation, (2) economic opportunity, (3) political empowerment, (4) educational attainment and (5) health & well-being. Women join from multiple sectors to attain these goals.

## AAUW Public Policy Principles Under Attack in California and in Washington, DC

### Partisanship in Congress Stops Progress on Issues

Rather than deal with the pressing issues facing the country such as continuing high unemployment, Congress has been focusing on the debt ceiling. Many members are demanding major cuts in all aspects of the federal budget, including entitlement programs such as Medicare and Social Security, as a condition for approving an increase in the debt ceiling. Little to no study has been made on the longer-term implications of the cuts being proposed.

Of particular concern to AAUW are potential changes to Social Security, such as reduction or elimination of benefits and potential privatization. Protecting and strengthening Social Security, one of our nation's best antipoverty programs, is particularly important to women.

All AAUW members should be concerned about the partisanship that is so divisive both in California and in Congress. Demand reasonable dialogue and compromises to move California and the nation forward!

### California Budget Cuts Education and the Safety Net

AAUW CA (in its Position Paper on the California Budget 2011-2012: Revenue, Reductions, Reforms) called for the extension of temporary taxes due to end June 30, 2011, cost-saving reforms and expense reductions. However, due to uncompromising partisanship in the Senate and Assembly, the tax extensions did not pass due to the required 2/3 vote. Instead, the state's 2011-2012 budget reflects assumptions that the economy will improve, thus generating additional tax revenues.

AAUW CA continues to believe that

this approach to achieve a balanced budget is an unreasonable solution, and harmful to all state residents. Sheila Kuehl, former California Senator and a budget expert, who spoke at the AAUW CA Convention in April, states the choices succinctly on her website: Under virtually any scenario, the most vulnerable in the state seem slated to continue to suffer a lack of support for even their most basic needs . . . Each of these budget "buckets"—[K-12] education, higher education, CalWORKS, healthcare, transportation, environmental protection, protection of our most vulnerable, public safety, emergency services—all of them are intertwined, none stands alone. Time will tell if the people of California see it this way, or if they will continue the fragmentation and dissolution signified by their votes (many of them against their own best interests) on the continuing plethora of initiatives."

## History of Title IX

The year Title IX became law was 1972. The bill sponsored by Edith Green and Patsy Mink in the House banned discrimination on the basis of sex in schools that receive federal funds.

At first it applied to women who were trying to get into law and medical schools. By 1974 emphasis began in women's athletics. Since the average Big Ten universities invested thirteen hundred times as much money on the average male athlete as on the average woman athlete, things were going to change. When Pat Shroeder visited a high school in her Denver district, the high school basketball coach told his team "Show Mrs. Shroeder what you think of Title IX." The boys turned around and mooned her.

Two examples of the short shrift girl's athletics were getting around the country that led to Title IX's passage were as follows: In Cedar Rapids, Iowa, where girls' sports got 9% of the athletic budget, the boys' tennis team had courts and the girls played on the school driveway, stopping whenever a motorist had to get through. The women at the University of Kansas had to drive overnight to get to some of their track meets, and when they arrived, they had to sleep on wrestling mats in the gym. The male athletes were put up in hotels and transported at the University's expense.

The source of my material is *When Everything Changed* by Gail Collins. I highly recommend this book to all members of AAUW.

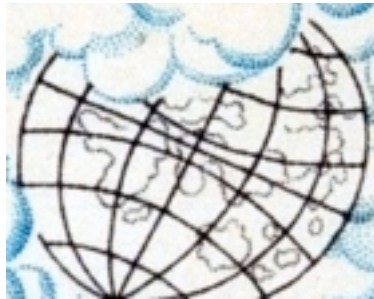
# Brush Up Your Foreign Policy Understanding

## Brief Overview of 2012’s Eight Topics

- Middle East Realignment;** by Augustus Richard Norton  
The popular revolts and upheaval of the Arab Spring have radically changed the face of the Middle East. What lies ahead for the Middle East’s transition to democracy?
- Promoting Democracy;** by Larry Diamond  
The U.S. has had a history of advancing and supporting democracy around the world. With a choice of tools ranging from economic aid to military force, what are the appropriate yet effective methods that the U.S. should use to promote democracy?
- Mexico;** by George Grayson  
Mexico’s border with Central America, as well as the border it shares with the U.S., is a pathway for people, goods, crime and contraband in both directions. How can Mexico address these challenges? How will Mexico’s foreign relations affect its domestic politics?
- Cybersecurity;** by Ronald Deibert  
The securitization of cyberspace has caused a sea change for both governments and the private sector, faced with new threats, new battlegrounds and new opportunities. How will the U.S. and its democratic allies approach the cyber frontier?
- Exit from Afghanistan & Iraq;** by Michael E. O’Hanlon  
Ten years after September 11, 2001, the U.S. is winding down its military commitment in Iraq and slowly pulling out of Afghanistan. What exit strategy will help Afghanistan and Iraq build stable democratic nations? What is the role of the U.S. in the Middle East’s future?
- State of the Oceans;** by Sara Tjossem  
The world’s oceans are essential to life on earth, and are very sensitive to global climate change. What are the consequences of climate change on oceanic factors like biodiversity, sea levels and extreme weather systems?
- Indonesia;** by James Castle  
Having emerged from authoritarianism in the last 15 years, Indonesia has made remarkable strides politically, economically and socially. The new, democratic Indonesia is still a developing country facing considerable challenges. What is Indonesia’s role in the global community?
- Energy Geopolitics;** by William Sweet  
The energy markets have been shaken by the instability of Middle East oil and the vulnerability of nuclear power. Moreover, developing countries like China are becoming bigger energy consumers, while energy producers like Russia see the opportunity to widen their influence. In this changed landscape, how will the U.S.’s energy needs affect its relations with other nations?

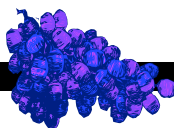
