## About the Authors of *Women's Ways of Leading*, Dr. Linda Lambert and Mary Gardner

For two decades, Linda Lambert and Mary Gardner have worked together as colleagues, friends and co-authors on books about leadership. They served in top-level leadership positions, engaged in research on women and leadership, consulted internationally, and mentored the next generation of women leaders.

Lambert and Gardner's work with constructivist leadership, leadership capacity, and women's leadership is creating new patterns of relationships among individuals and within organizations, resulting in the fuller democratization of leadership. Such democratization ensures a resilient and replenishing fabric of leadership, the essence of sustainability.

Mary Gardner is the former superintendent of the Saratoga Union School District (Saratoga, California), a visiting practitioner at Harvard University, and a professor of educational leadership. She consults with non-profit organizations and has served on five boards of directors.

Dr. Linda Lambert is also lead author of *Who Will Save Our Schools?*, three books on leadership capacity and dozens of articles. She worked to set up community schools for girls in Egypt and advised organizations in Canada, England, Malaysia, Thailand, Australia, Mexico, and throughout the United States. A former social worker, school principal and university professor, Lambert is the president of Lambert Leadership Development, The Sea Ranch, California.

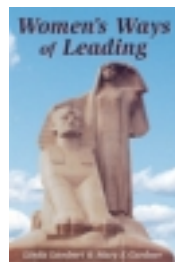

In the years that followed, the women's leadership studies were expanded as broader study arenas were identified. In addition to the San Francisco Bay Area, where both women lived, Los Angeles, Seattle, the province of Alberta, Canada, and Malaysia became centers of inquiry. Themes emerged as women from the various places, ages and careers responded to questions, told stories and entered into dialogue with each other. The experiences of the women were remarkably similar, the struggles familiar. Gender issues became predictable, yet the level of maturity significantly influenced how each woman related to the themes. ## California's Public Policy Debate Discuss Reforming the California Initiative Process

*What is your opinion about how the current California initiative process works? Does the initiative process seem to serve special interests rather than the public good? What can be done about the California initiative process?*

The 2011 AAUW CA study of the California Budget has drawn attention to the dysfunctional state budget process and has recommended reforms for consideration by the legislature. Branches have since indicated interest in doing another study and the selected topic is *The California Initiative Process*.

## Support Access to Preventive Care and Contraception!

We have some good news and we have some bad news. The good news is the Department of Health and Human Services (HHS) is considering adopting the Institute of Medicine's (IOM) recommendations that women's preventive health care be completely covered by any new health insurance plans under the new health care reform law!

The bad news, unfortunately, is that efforts are underway to expand "religious refusal" exemptions. If expanded, certain employers would be exempt from having to provide coverage for contraceptive services to their female employees if the employer is opposed to contraception.

An expanded exemption would allow an employer to deny their employees access to care that doctors, medical associations, and the IOM consider

necessary. Besides, with or without an employer exemption, if an employee is opposed to contraception on religious grounds, she's unlikely to fill a prescription for birth control. But these exemptions are also a little sinister.

Religious refusal provisions allow the decision-makers at "religious employers" to determine what sort of contraception, if any, their female employees will have access to. If the existing religious refusal exemption is expanded, it would create a broad definition for "religious employers," and could impact all employees at some schools, hospitals, charities, and elsewhere – even if the employee does not share the faith of their employer.

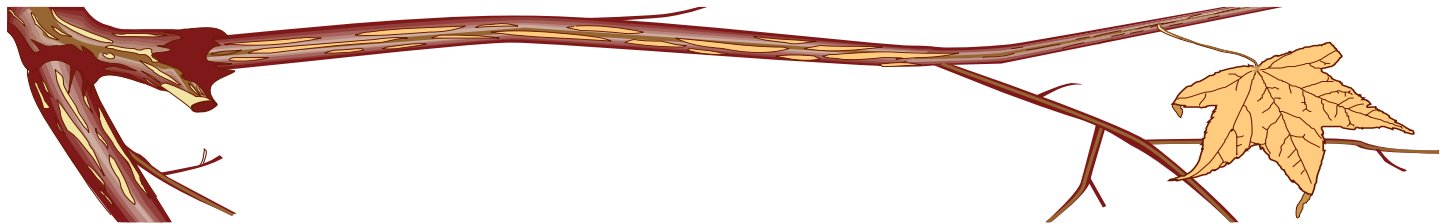
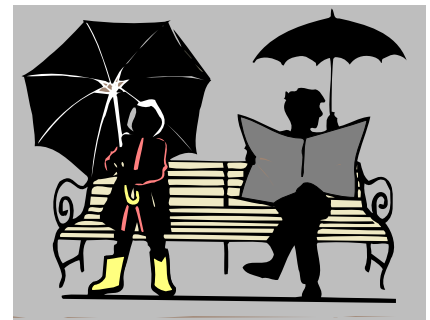
Here's more good news, however: HHS is currently waiting to hear from the public! That's right – AAUW has a
