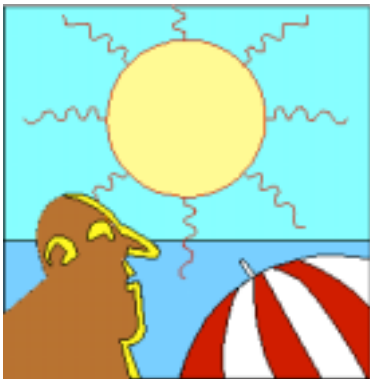
also have representatives from the interest groups and committees there to talk about what they do and to give you the opportunity to sign up.

## A New Approach to Branch Fundraising

At the Board meeting in June, there was a spirited discussion about the way our branch raises money for our various local ISPF projects. Our branch members generously support *Tech Trek* to send junior high girls to the summer science camp at Stanford, *Local Scholarships* to help college women transition from West Valley College to four-year universities, and the *Committee for Homeless Women and Children* to provide needed services and supplies.

Although each committee works hard on its own event or events during the year, the results over the past few years have been somewhat disappointing. Over the summer all three committees met and decided to organize one “*big*” event to be held this coming spring, and one special “*appeal letter*” sent this fall, with the proceeds to be divided among the three local ISPF programs. The most obvious benefits are that the work and help needed to put on a successful event will be shared by all three ISPF committees, and we will limit the number of times we ask our members for financial support.

Our event will build on the popular and very successful *English Tea* put on for many years by the Committee for Homeless Women and Children. We urge you to you mark your calendars now ~ Saturday, April 27, 2013, 2:00 to 4:00 pm, at West Valley College. *Watch the Grapevine for details.*

Many members donated to our local ISPF projects when they renewed their branch membership. Our “*appeal letter*” will be mailed in mid-October and provides another opportunity for you to make a direct contribution to any of the local projects. Of course, donations are tax-deductible and can be made at any time. *Your generosity is truly appreciated!*

Because of the timing this year, this change will NOT affect the *West Valley Chorus Performance* – benefits Local Scholarships (*see the flyer in this Grapevine issue*) already scheduled for October 2, 2012. Also NOT affected is the annual *Authors’ Luncheon*, on January 23, 2013, that benefits AAUW Funds (the national educational program). This luncheon is always one of the highlights of the year, extremely popular and an enduring branch tradition. Committee on  
Homeless Women  
and Children**

The Committee assists The George Travis Center, Commercial Street Inn, The Villa, Family Supportive Housing in San Jose and St. Luke's Pantry in Los Gatos.

**GEORGIA TRAVIS CENTER**

Georgia Travis organized the Committee on Homeless Women and Children. She noticed that shelters were closed from 8:00 AM to 5:00 PM. Where did these women and children go during this period of time. With persistence and funding from the San Jose Junior League, the Georgia Travis Center was opened. The Georgia Travis Center is a drop in center for homeless women and children. Clients can have voice mail, take a shower and do their laundry. Some of the other services offered, are counseling, assistance in how to find a job, and interviewing techniques, a mobile medical clinic comes once a month and each client has a case manager.

**COMMERCIAL STREET INN**

Commercial Street Inn, is across the street from GTC, is an emergency shelter for women and women with children for up to 90 days. There are 12 family units and 15 private cubicles for single women. Due to the design of the facility boys over the age of 12 are not permitted. Clients can stay 90 days. Women pay a small program fee after the first 30 days. While in the shelter, women work closely with a case manager to secure transitional or permanent housing. Meals are provided and all residents assist in daily chores.

## **NEWS Continues ... Committee on Homeless Women and Children**

### **THE VILLA**

The Villa provides transitional housing for single women, with children. A community kitchen, common rooms, play area and computer lab are available to all residents. Individual units are wired for telephone service. The Learning Zone Homework Club is offered twice a week for school age children. Case management is part of the program. Residents must be employed and pay 30% of their income for rent, and maintain residency for two years.

**FAMILY SUPPORTIVE HOUSING**, has just opened a new facility. It is the only facility serving families. Each family has their own room and bath. Meals are served in a communal dining room. Most of the families have full time employment, but don't have the income for the expensive rents in The Valley. There are many services offered, including budgeting, parenting, English as a second language, and after school tutoring for the children. Families can stay for 90 days. The Committee on Homeless Women and Children support the summer camping program. The children attending camp are provided with new clothing and other camping necessities, so they look like any other children going to camp.

**ST. LUKE'S PANTRY** is an outreach program hosted by Saint Luke's Episcopal Church to serve the homeless in the Los Gatos a church area. The pantry is open in the parish hall at 10:00 AM on Tuesday mornings to provide food, companionship and clothing. This program receives funding and support from the members of St. Luke's, from other churches in Los Gatos, and the Los Gatos Community.

A reminder to save the toiletries you find in hotels and motels while traveling. We send these to GTC.

The ISPF annual English Tea will resume this spring on Saturday, April 27th at West Valley College. This year the Tea will be a joint ISPF event of The Homeless Committee, the Local Scholarship Committee, and the Tech Trek Committee. The profits will be shared by the three groups. It is not too early to save jewelry for the jewelry table, and items for the silent auction.

## **Teacher Corps Program to Boost STEM Education**

The Obama administration announced a \$1 billion Master Teacher Corps program for teachers, which will focus on improving student success in science, technology, engineering, and math (STEM). The Master Teacher Corps program will select 2,500 STEM teachers from all 50 states to share knowledge and skills with each other in an effort to boost student success. As an incentive to join the program, teachers in the Corps will receive a \$20,000 pay raise. As part of the administration's ongoing efforts to produce 100,000 additional math and science teachers in the next 10 years to help close the gap between American students' success in STEM and that of their international peers.

AAUW strongly supports efforts to incentivize STEM teaching and promote STEM education. The shortage of American scientists threatens our nation's ability to compete and innovate in the coming years. Efforts like this will help increase America's competitiveness by enhancing STEM education for all students and hopefully encourage more girls to pursue these fields. Supporting women and girls in studying STEM fields is a vital part of AAUW's mission.

## **House Appropriations Bill Enacts Deep Spending Cuts, Defunds Health Care Law**

The House Subcommittee on Labor, Health and Human Services passed an appropriations bill that would cut \$6.3 billion from federal spending in fiscal year 2013. Among other cost-cutting measures, the bill would end the Obama administration's signature Race to the Top education initiative and would defund implementation of the Affordable Care Act among other cost-cutting measures, while increasing the budgets for Pell grants and the Head Start program. All subcommittee Democrats voted against the bill, along with Rep. Jeff Flake (R-AZ), who had wanted deeper spending cuts.

Although AAUW recognizes that these are tough budgetary times, a balanced budget should not come on the backs of students, women, and working families. As Congress grapples with difficult budgetary trade offs, it is vital that we maintain programs that promote job creation and economic security, expand educational opportunities, defend civil rights, and protect women's health.

## Gifts for Teens Holiday Sweatshirt Drive

Although currently it's still warm outside, Gifts for Teens is seeking cash donations to purchase cold-weather gear for street kids and low-income Silicon Valley teenagers. Warm sweatshirts are number one on the wish list for these impoverished teens. We would like to provide each teen with a sweatshirt, adding them to the gift bags that Gifts for Teens distributes to 1,350 needy teens in December.

Funds have already been collected to buy 550 sweatshirts, yet another 800 teenagers will be left out in the cold without some additional donations. ### Orzo Salad with Cucumber and Feta

This salad is a delicious accompaniment to fish, chicken, beef or pork – or it is just as good all by itself.

Makes: 4 to 6 servings

8 oz. dried orzo (about 1 cup)  
 1 bunch scallions, chopped  
 1 medium cucumber, peeled and diced  
 1/2 cup chopped, pitted kalamata olives  
 1/4 cup sun-dried tomatoes, julienne cut (optional, you can use red bell pepper, diced, if you prefer)  
 8 oz. (1 cup) Feta cheese, crumbled

#### DRESSING:

1/3 cup Canola oil  
 1/3 cup freshly squeezed lemon juice  
 2 cloves garlic, minced  
 2 tbsps fresh dill, minced or 2 tsp dried dill weed  
 1/4 tsp dried oregano, crushed  
 Salt and pepper, to taste

1. **Make the Dressing.** In a jar, combine all the dressing ingredients and shake to mix well. Refrigerate until needed. You can make it a few days in advance, if you want. Shake before using.
2. **Cook the Orzo Pasta.** Cook the orzo according to the package directions and let cool until just warm. (I cooked the orzo for 7.5 minutes until it was al dente.)
3. In a large bowl, combine the cooled orzo, scallions, cucumber, olives, sun-dried tomatoes (if using) or the diced red bell pepper and the crumbled Feta cheese.
4. Pour 3/4 of the dressing over the orzo salad and toss to blend. Taste and adjust seasonings and add more dressing, if needed. Cover and refrigerate for at least 3 hours until ready to serve. (*Can be made the day before.*)

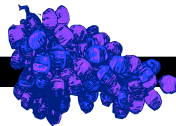
